planning application. We are also looking at having him provide inspections for all the work.

The committee has built a presentation board that is now located in the clubhouse, displaying the pool drawings and information about other building elements. We hope the information informs the membership on some of the technical work that is going on. Remember the committee established a project book that is maintained by the office, which holds the majority of communication and discussion documents. You are welcome to view this.

Roads & Drains Committee

Members: Dave Paquette (Technical Chair). Brian Corrigan (Contract Admin), Mike Noel (Technical Advisor) and Ken Parsels has moved into Board Liaison. A meeting was held with our park lawyer to discuss the complaint that was sent into Southwest Florida Water Management. We can confirm that this has been forwarded by them to Lee County and an inspector has visited the site. The resident, together with the Roads & Drains Committee attended the meeting.

The meeting was held to understand our next steps moving forward and also to evaluate how we got to this stage within the community. The resident voiced his upset at bringing forward a complaint that was not acted upon. Upon occasion we will get a bad performing contractor and the BOD are open to establishing "good practices" on contracting to minimize these issues in the future.

Please remember to take care in crossing the road dip at this time. A cone is in place as a visual warning, along with a sign and the maximum speed throughout the park is 15mph

The Roads & Drains Committee have been able to survey the road dip (Shrub Lane North) and the canal drain. They are looking to engage an engineer to obtain permits and work with Lee County.

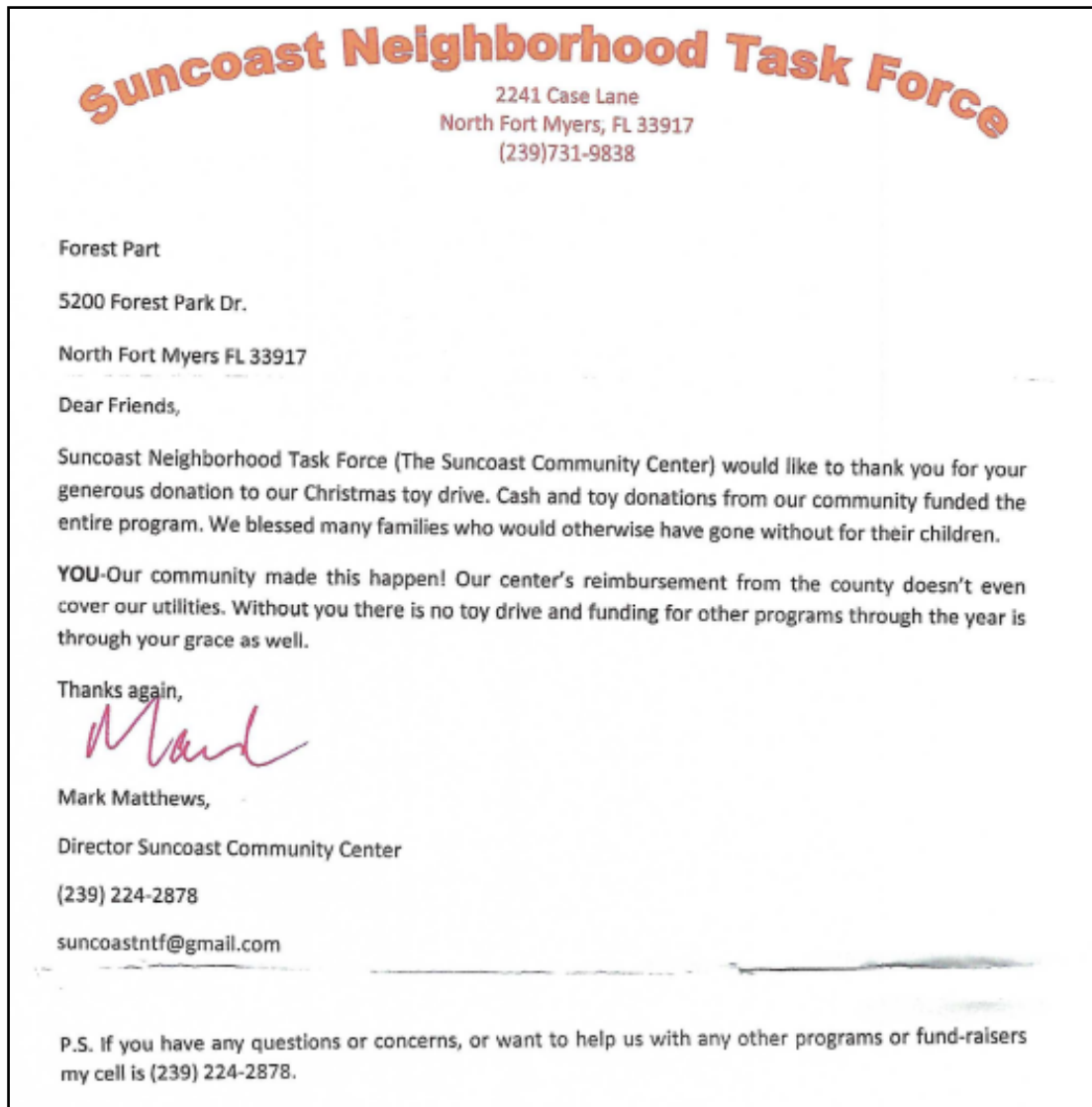

HAZARDOUS WASTE

Lee County has very strict regulations regarding hazardous material disposal. The Board voted to approve the initiative to have all residents place paint, pesticides, chemicals, florescent bulbs and gas bottles at curbside.

Park employees will pick up these materials on Tuesday and Friday and log them in. These articles will be stored and disposed of in the appropriate manner by staff members.

The rules and regulations have been changed to reflect the process.

GREEN TREE STICKER



There is a little green tree sticker available in the office that goes on the LEFT SIDE OF YOUR BACK WINDOW of your car. All residents with automobiles should have this highly visible authorization to be in the Park. This will help the safety patrol on their nightly rounds. We appreciate our residents understanding that our system will benefit from upgrading in order to service the 300+ residents who are using the WiFi every day. For anyone that could not attend the last members' meeting on January 27, 2022, the explanation for the increased expenditure in 2022, can be picked up at the office.

Four of us sat with Ethx, the company who provides us with technical service and advice on Friday, January 28, while we shut down our system so they could "tune" our system through the computer in the clubhouse. Changes were made to alleviate some of our residents' problems with buffering and connections dropping in and out. Many of the problems with TV buffering and can be helped by setting your resolution on the TV down to 1080 or 720.

The Forest Park WiFi committee and volunteer group, would like to provide a means of residents communicating to us with their thoughts of either pros or cons of how our system is working.

We now have a Yahoo email account dedicated to this, and it will be checked on a regular basis by the group. One of us will respond by email with help. If your system goes down completely, you of course will not be able to reach us by email, so you can contact one of us by phone and we can schedule a visit to see what the problem is. Please keep in mind that it is appreciated by all volunteers to keep park business to week days and allow us family time on the weekends.

If a new antenna or upgrade is required, the present

cost is \$120 for the antenna, \$25 for a router and \$10 for a new cable.

For installing an antenna if you cannot do it yourself, contact Gerry Bauer – 239-849-0317 and for a reasonable fee he will do this for you.

Trouble Shooting

1. Unplug your antenna and router, leave them unplugged for at least 1 minute so this re-boots your system. **Note** – starting the antenna before the router is best so that the router can "find" the antenna as it re-boots.
2. If it fails to come back up please call one of our group and they will check your connection remotely, and if they see something wrong, then schedule a visit at your home.

RESIDENTS – PLEASE BE AWARE COMPUTER ATTACK!



A resident reported that her computer screen suddenly froze, with a warning that Microsoft had locked it due to a financial attack. The warning advised to call a phone number. Our

resident turned her computer off, then on again several times, but each time the message came back. She then called the number and the respondent confirmed she was talking to Microsoft. The issue was with a charge to Discover that was related to a child pornography, to please hold a moment and she would be advised of the Discover number to call, meanwhile, to click the on-screen link.

When called, the Discover respondent confirmed the resident's account number, several valid transactions, and the fact that \$7,000 had been charged. Our resident watched the mouse cursor move as the Discover person navigated her on-screen Discover records. Then, the Discover person indicated our resident could recover the charged funds by purchasing three gift cards totaling the \$7,000.

At this point our resident hung up, and called the true number for Discover. The agent advised that this fraud attempt was far from unique. Hackers have become so skilled that they can "take a crumb and hack into your computer". Discover had seen the charge attempt and blocked it. Our resident closed the account.

The resident's computer had used Teamviewer software on her computer to allow a relative to take control and demonstrate some computer actions. This software is popular and has a reputation as secure. But perhaps it has a vulnerability to hacking, which our resident exposed when clicking the advised link.

As a matter of interest, the attacked computer was connected to the internet through the local phone company, (the resident has a phone/internet package). It was NOT connected through the park's WiFi.

Whatever the reason, computer users should keep important files, (pictures, documents, personal videos etc.) backed up onto a flash drive or in cloud storage like g-mail drive. Then, if the computer is hacked so it will not boot, a technician can purge it and re-install a fresh operating system. Members of the computer club

can often get access to a blocked computer with a live operating system on a flash drive. Then files that are not already backed up can be retrieved.

Most important, - if it happens to you, do not call the "Microsoft" number on the locked screen. The correct number is 1-800-642-7676.
