

PRESIDENT'S MESSAGE FEBRUARY 2013

Congratulations to Richard Taylor and Jack Watson on their election as Directors for the next three years.

Richard was appointed last year to fill out my term as Director and will now be continuing for three more years. He has done an extraordinary job of watching over our drainage system, ponds, pumps etc. and is now also in charge of our mechanical equipment and has oversight authority of our maintenance department. Richard did a great job last summer in evaluating the problem with the Putt Putt sink holes and recommended a \$2500 solution rather than the \$100,000 solution which was recommended by a contractor. He is dedicated to getting us the most “bang” for our “bucks” in all repairs and purchases.

Jack has extensive experience in the landscaping arena, owning and running a landscaping company and now helps out when the new manager, his daughter, needs help. Jack and Judy have been active in Forest Park for years and this year have really thrown their hats in the ring with Jack as a Director and Judy editing the newsletter. I have asked Jack to take over the responsibility for our “Grounds” which includes maintaining the beautiful appearance of the common areas and the preservation and management of the “Memorial Garden”. Jack will have help available to him from Becky Conrad and Jerri Duchesne. We are fortunate to have Richard back with us and Jack joining the team.

I have asked Betty Campbell to be the Board Liaison with the Social Club in addition to her duties as head of Mediation. Betty's people skills and extensive experience with social functions and service on the Board, as President and now 1st Vice President, should provide seamless communication and cooperation between the Board and Social Club. I have also asked Betty, in her role as head of Mediation, to do a survey of the houses in the park and pick out the ones in need of power washing, upkeep, lawn care, illegal storage on patios and other violations of our rules. Betty is good at “nudging” us into compliance with the rules. Sometimes we (and I include myself) get so busy with other things that we don't pay

particular attention to the slow deterioration of our homes and just need to be reminded.

If Betty's “nudging” doesn't work and in those cases where it is necessary, she will refer the matter to the Administrative Review and Appeals Committee. The Committee, composed of myself, John Wright, Bob Lang, Jim Barnett, Lou Smith, and Jan Orlando will have a hearing to see if there are extenuating circumstances to be considered, and will try to resolve the matter. In most cases we get cooperation and resolution of the problem. In those cases where we are unable to reach an amicable solution, we will continue with those enforcement tools at our disposal including; having work done and assessing the cost against the property, legal action, and finally, law suit. In most cases we will have an acceptable solution

Our secretary Bob Lang will be in charge of the Office, along with responsibility for all records. Bob has faithfully recorded Board and FPPOA Meetings in the last year and worked with Bob Geisler to put them on the Forestparkonline.com website.

Mary Diaz, our Office Secretary is such a nice person and tries to be helpful to all who come into the office. The problem is that too many people think of her as their personal secretary and it is just taking too much of her time. We have cut the office hours down to give her quiet time after 12 o'clock to do all of the accounting and routine duties which must be done. But we are still getting people coming to talk to her after hours.

I am asking all residents, including Board members, to respect her need for quiet time to be able to focus on those necessary duties. Please do not expect Mary to spend time with you to fax, copy, and all the other things, which she is called on to do. I don't want to tell her to stop all assistance but if we must, we will. Mary is there to receive maintenance payments and provide information and answer questions from residents, not to provide secretarial services to 435 residents. I go to Office Max if I have personal faxing to do and if you don't have a computer with a printer for copying, we put one for your use in the large room of the activity building. So please do not bother Mary more than is absolutely necessary.

I started to write an article commending all of the Forest Park volunteers for their time and service. It got to be two pages long and I was afraid I would forget to mention someone so I decided not to list each individually. We have close to 100 people who contribute in one way or

another in the service to Forest Park. Look on pages 3 and 4 in your new phone book to see the list of “leaders” who Mary has identified. Most of the leaders also have numerous people helping them. We are blessed to have so many people willing to give of their time and energy. We also have residents that have businesses who sell their products wholesale to the park and skilled tradesmen like Dean Hull who we call on for electrical problems and the “builders”, Brooks, Moon, Emery, Lang and others who rebuilt the shed, we can’t forget to thank them also.

While I don’t want to continue naming volunteers, I feel that I must also call attention to Dave Small and John Wright for the many hours they have worked and continue to work on bringing our accounting procedures up to acceptable standards so that we will be able to fully report and answer to the membership. They have worked tirelessly and doggedly with our accountant, Stroemer & Company to get the information and reports that Dave, John, Anna Thatcher, and Mary think are needed. Dave and John have gone over records from the last several years to identify areas where improvement is needed. Stroemer has been very cooperative and have given us all of the information and reports which we contracted with them to do, and are working with their software company to get the additional info and reports that Dave thinks we need in order to reach “perfection”. I am usually satisfied with things being “pretty good”, but my buddy Dave insists on perfection, and is working to attain it.

I must also commend Mary for the amount of extra work which is required in the initial stages of this project. Mary is always agreeable and has worked through many lunch breaks to get the work done. We are very fortunate to have her. And my thanks also to Anna Thatcher who lends her expertise as a former CPA to guide us away from problems, and Sherrill Wright who is always willing to fill in so Mary can attend discussions and meetings.

So to all of you volunteers who so freely give of your time, I say, THANK YOU!

P.S. As an afterthought, it seems that with all of the willing volunteers we have, there is difficulty maintaining members and especially officers in our “Clubs”. I note that the Ohio Club has disbanded because no one was interested in serving as officers, and the Michigan Club disbanded because of low attendance. Also, attendance is down at dances and shuffleboard. What is this all about?? Is there something that can be done to improve in these areas? If you have ideas or suggestions, I am sure Deloris

and Ray Preston would be glad to hear them.

P.P.S. One more thing, I just returned from watching and carrying the water bucket for the guys replacing an antenna for the WiFi. There was Doug, Bob G, Ron, John, Ray H., and a couple of others whose names I don’t recall, working to drop the tower and install a new (one of several) antenna. Anyway, very sad to see these, mostly very young, people being charged as felons, knowing that conviction will forever be a black mark on their record which is difficult if not impossible to overcome. So many troubled youth in this country now, many of whom might not have been tempted into crime if decent jobs had been available to them, as they were for my generation.

Our guy came in with handcuffs on and was arraigned with court dates set for early February. No way can he make bail and I expect him to plea down to lesser charges but with so many cases pending against him, I expect he will be in the “can” for years to come. This is so sad for him, but so good for Forest Park. I feel that he is the one responsible for all of the recent break-ins and with his incarceration and the publicity we received for our cameras and help in catching him, I think the bad guys will avoid Forest Park. Let’s keep our guards up but cease worrying and start again enjoying our retirement.

FPPOA PARK PLANNING

With the problem of Sink Holes in the land south of Maintenance/Bocce Courts, it has been brought to our attention of what should we do with that common property. We will have to relocate the Putt-Putt Course and the placement of a possible Hobby Shop building which may require the use of some of that space. There is general acceptance that the Memorial Garden is a great idea, but how large an area is required. Another way of looking at this is how much green space do we want in that area. We only have a limited area for future amenities and how do we set aside space for that possibility should some members want a volleyball court, tennis court, member garden plots, etc. can this be accommodated in this area.

I am not suggesting that the planning already taking place for these projects should be delayed as Lee County is now evaluating the possible site for the Hobby Building and the Putt-put evaluation is presently underway. Both of these projects will require Board and membership approval. A preliminary estimate to reclaim that area of the sink hole was over \$100,000. This is a lot of money but any land such as this would be expensive to buy. I would like to create a committee reporting to the Planning Group to develop an overall plan. To deal with this issue I would expect that it will take until the end of the year to complete and any such plan will need to be submitted to a combined Budget/Planning group for approval. The Board of Director's should then review and if approved go to the general membership for final approval. This official plan could then be used for future development. I would hope that this process would include anyone who has an interest to participate in this transparent plan. Anyone who is interested in this committee should contact me as I suspect that we may have a large number of people with an opinion wanting to participate in this process.

After this process is completed we should also look at Peace Lake area as well as the R.V. Parking area to determine what, if anything should be done to those areas and involved in our official plan.

FOREST PARK WIFI

The Forest Park WiFi system is a relatively recent addition to our amenities. It has the capability of providing "normal" internet usage for everyone in Forest Park. "Normal" internet usage involves email and web surfing, including reception of small "YouTube" and similar videos. The system is technically incapable of supporting internet television for everyone. "NetFlix" and similar web-based television systems take up much more of our system's resources than it can reliably carry. Some satellite-based TV systems, (e.g. Direct TV), are now offering web-based TV programming in addition to their satellite-based programs. These "free" offerings are internet-based and attempts to use them will put a heavy load on the Park system. Anyone attempting to receive internet-based television programming through the Forest Park WiFi system is using far more than their fair share of the system. Please do not attempt to run internet-based TV on our system.

Usage and load on our system is monitored by our dedicated technical supporters of the system. If you attempt to receive TV programming through our system, they will detect your heavy usage and adjust the system so that other users are not deprived of access to the internet. This adjustment is likely to limit your reception of internet-based TV programs and will probably prevent smooth running.

To run internet-based TV, you need an individual internet connection as provided by Century Link DSL. This travels through the telephone lines and must be installed by Century Link technicians.

Other TV options, such as Prism or regular satellite dish-based systems, do not affect the park WiFi system. A variety of programming is available.



CHOCOLATE ALMOND PROTEIN BARS

This is a very tasty, sugarless bar that contains lots of protein, good vitamins and minerals and healthy fats.

Base

- 2 cups almond flour
- 1 cup ground flax seed
- 1/2 cup unsweetened shredded coconut (optional)
- 3 scoops chocolate Whey Protein
- 1/2 cup xylitol sweetener(or erythritol)(these are natural non-chemical sweeteners)
- 1/2 teaspoon cinnamon (optional)
- 1/2 cup coconut oil
- 1/2 cup organic butter
- 3 squares unsweetened baking chocolate
- 1/2 teaspoon pure vanilla


Topping

- 4 squares unsweetened baking chocolate
- 2 tablespoons coconut oil
- 1 tablespoon organic butter
- 1/4 cup (or more to taste) xylitol sweetener
- 1/2 teaspoon vanilla

1. Place almond meal, flax meal, shredded coconut, chocolate Whey Protein, cinnamon and xylitol in a food processor.
2. Pulse until ground into a meal.
3. In a double boiler melt coconut oil and butter. After melted, add 3 squares of chocolate.
4. Once melted, remove from heat and add vanilla.
5. Place dry mixture into a large bowl and add liquid chocolate and mix into a paste.
6. Press mixture into an 11" x 7" or 8 "x 8" glass baking dish.
7. Chill in refrigerator for 1 hour, until mixture hardens thoroughly.
8. After mixture is chilled, heat butter and coconut oil in a double broiler until liquid.
9. Add xylitol and heat and stir until thoroughly dissolved.
10. Add 4 squares of chocolate. Stir until melted.
11. Remove from heat and add vanilla.
12. Pour melted chocolate over chilled pressed mixture in glass dish. Return to refrigerator until chocolate hardens.
13. Removed from refrigerator, cut into bars and serve. If chocolate cracks when cutting, let soften for 10 -15 minutes first.
14. Keep refrigerated. These also freeze well.


