He complimented Forest Park on their Security Program stating it was more effective than all surrounding retirement parks, including gated communities. The reports of stolen property and vandalism were much less than other surrounding parks.

Several factors contributed to our success including an outstanding volunteer force, strong historical security leadership, support of the park governing board, better attention to locking property, security cameras, visibility of security, and resident community support.

Bicycles, golf carts, and auto contents from unlocked cars were some of the most common stolen items. It is very important to keep our cars, houses, outside property such as bicycles, golf carts and grills secured with some sort of locking device.

HELPFUL THINGS TO KNOW (This is a repeat notice)

The information listed below has been in our Newsletter before, but for those that may have missed it, it is worth repeating.

Five Things You Never Knew Your Cell Phone Could Do

For all the folks with cell phones. (This should be printed and kept in your car, purse, and/or wallet. Good information to have with you.) There are a few things that can be done in times of grave emergencies. Your mobile phone can actually be a life saver or an emergency tool for survival. Check out the things that you can do with it:

FIRST - Emergency

The Emergency Number worldwide for Mobile is 112. If you find yourself out of the coverage area of your mobile network and there is an Emergency, dial 112 and the mobile will search any existing network to establish the emergency number for you, and interestingly, this number 112 can be dialed even if the keypad is locked. Try it out.

SECOND - Have you locked your keys in the car?

Does your car have remote keyless entry? This may come in handy someday. Good reason to own a cell phone: If you lock your keys in the car and the spare keys are at home, call someone at home on their cell phone from your cell phone. Hold your cell phone about a foot from your car door and have the person at your home press the unlock button, holding it near the mobile phone on their end. Your car will unlock. Saves someone from having to drive your keys to you. Distance is no object. You could be hundreds of miles away, and if you can reach someone who has the other 'remote' for your car, you can unlock the doors (or the trunk).

THIRD - Hidden Battery Power

Imagine your cell battery is very low. To activate, press the keys *3370#. Your cell phone will restart with this reserve and the instrument will show a 50% increase in battery. This reserve will get charged when you charge your cell phone next time.

FOURTH - How to disable a STOLEN mobile phone?

To check your Mobile phone's serial number, key in the following Digits on your phone: *#06#. A 15-digit code will appear on the screen. This number is unique to your handset. Write it down and keep it somewhere safe. When your phone gets stolen, you can phone your service provider and give them this code. They will then be able to block your handset so even if the thief changes the SIM card, your phone will be totally useless. You probably won't get your phone back, but at least you know that whoever stole it can't use/sell it either. If everybody does this, there would be no point in people stealing mobile phones.

FIFTH - Free Directory Service for Cells

Cell phone companies are charging us \$1.00 to \$1.75 or more for 411 information calls when they don't have to. Most of us do not carry a telephone directory in our vehicle, which makes this situation even more of a problem. When you need to use the 411 information option, simply dial: (800)FREE411, or (800) 373-3411 without incurring any charge at all. Program this into your cell phone now.

An extensive review of the expenses and problems with comfort in the clubhouse and activity buildings has been done by the Building Interiors committee.

It has been decided that the covers on the thermostats will be removed.

Event chairpersons may adjust the temperature for an activity to desired levels. At the end of the event or activity thermostats should be returned to the economy settings.

We ask that everyone help to conserve energy and help to provide savings in utility costs by ensuring that we are not wasting energy.

Please check to see that economy settings are used as much as possible.

BUDGET AND PLANNING REPORT TO MARCH 21, 2010

The budget and planning committees conducted three meetings with members to develop the budget proposal for 2011, and to develop a proposal for the allocation of improvement funds that were approved in the 2010 budget. These meetings were discussion forums where all members were invited to bring their ideas and to seek support for them. In between meeting with members, the committees met to review and analyze our finances to ensure that the 2010 improvement funding did not need to be amended.

Budget 2010 improvement items

The proposed options for allocation would use only \$31,000 of the \$37,000 that has been approved. The committee recommends approval of the three items on the 2010 ballot sheet because they are:

- * Within our budget,
 * Will enhance the Forest Park life style, and
- * Improve our property values.

Initial proposal for 2011 budget

The expense items on the budget proposal for 2011 continues full funding of reserves. It also provides

\$60,000 for improvements. This is based on very careful analyses, increased monitoring of operating expense, and some austerity measures. Budget detail is provided in the document and voting will be at the end of this year.

Pending Reserve Items

The amounts required for reserve expenses are calculated often enough that we are always prepared for them, but the timing is often somewhat flexible. As major items approach, we draw upon the experience and assistance of all FPPOA members before bringing them to vote.

Sealing of roads

It has been suggested we look into sealing of our roads to extend their life. Information collected to date indicates that sealing is not cost-effective and it is not included in the calculation for the time to restoration. If new and improved sealing processes can be shown to extend the time between repaving, their inclusion in the equation can only be beneficial.

Modification of clubhouse.

Our reserve funding calculation includes all infrastructure including eventual replacement or total refurbishment of everything the Park owns. It has been proposed we consider modification of the Clubhouse to remove the pillars that currently block the view of the stage. The foremost two pillars, in particular, impair the view of the stage to a degree that spoils plays or similar performances.

An initial engineering overview indicates that modification is possible and might cost about \$45,000. This is close to the current portion of the fund reserved for Clubhouse restoration. The alteration would bring the space and style of the clubhouse up to the standard of modern parks and would enhance our property values. However, we need a more thorough engineering study, and the engineering firm that looked at this two years ago, is prepared to extend that study. For about \$1,500 they can complete the work to the point where we can request construction bids. The planning and budget committee recommends this be approved.

A Synopsis of the March 2010 FPPOA Board of Directors Meetings

Thursday the 4th

There are currently two small spaces and one large space available in the RV Storage area. Please call Pete Lawrence to request an application. FPPOA is monitoring our legal fees and setting up procedures that will hopefully help us in solving problems before they end up needing attorney advice. The sign variance application procedure with a limit of two magnetic signs per vehicle was approved by the Board of Directors. Three applications were received and approved and they were Sharon Goudy's Pre-Paid Legal Services, Inc., Bill Lachemayer's Landscaping, and a sign advertising Mona-Vie a health supplement drink.

The clubhouse

siding project is progressing. The pool deck area crack repair project has been completed. It was stated that residents should report developing holes in their yard to a Board Member. If holes suddenly develop in the yard, it could be a warning of more serious problems. Please do not just fill in the holes.

Ren Whitaker will take over as head of Security and the committee will be combined with the Neighborhood Watch committee. Ren will work with Ken Warner who heads up the Neighborhood Watch committee, to make our homes and streets safe for all.

A ballot for the vote on changing some of the bylaws and a ballot for the vote on proposed improvements will be presented at the March 25, 2010 General Membership Meeting.

Thursday the 18th

The issue of trash and the horticulture contamination was discussed. Letters containing the new lock combination were sent to all residents who have spaces in the RV area. Look for an article from Pete Lawrence in the newsletter regarding use and abuse of the RV and Trash area.

The Martel case has been dismissed without prejudice. This means that, if necessary in the future, FPPOA can re-open the case at any time. A professional collection service has been retained to try to collect some outstanding monies owed to FPPOA by Complete Arbor. The Legal Committee held three mediation hearings in March and all three were resolved amicably. Look for Bob Dickerson's article in the newsletter.

An expenditure for maintenance on the shuffleboard court was endorsed. Signs in the park are being upgraded to today's standards. Bids are being taken for tree trimming and for perimeter fence repairs.

Budgets were discussed and the final meeting of the Budget Committee was held on Friday, March 19, 2010 at 11:00 a.m. WIFI is still a work in progress. Channel 5 and 61 are up and running.

The Quilt Club meetings have moved to the Clubhouse. The construction at the FPPOA Office will begin at the end of March. Programmable thermostats were cancelled in favor of leaving the cover off the thermostat in the clubhouse and asking anyone making changes to the settings that they put it back to the stated temperature on the signs that will be posted at the thermostats. Hurricane preparedness was discussed and a task list is being designed to tell those who remain here in the summer what needs to be done and in what order.

A decision was made to contribute to the Florida Resident Owned Communities Association in order to have a voice at the State level. A petition to urge our leaders to act on changing the current law that limits coverage by Citizens Property Insurance Corporation on mobile or manufactured homes built before 1994 to actual cash value rather than replacement value, is in the clubhouse. Every resident is encouraged to sign it. Our premiums keep going up and our coverage goes down.

Jim Ullrey was appointed to the Board of Directors for the remaining of 2010. He will be eligible to run for the Board in January 2011.

NOTICE TO ABSENTEE OWNERS

This is to advise owners of property in Forest Park of their ongoing responsibility to properly maintain their property, including grass and landscaping, in an acceptable manner. This becomes a problem in the summer when many of the FP residents return to their northern homes or when homes are listed for sale and there is no occupant.

Section 3. of the Deed of Restrictions allows the Grantor (FPPOA) to have work done and charge the owner for the service if the owner does not correct the violation within a reasonable time. It requires the owner to pay for such services within 10 days from billing.

We do not want to become unreasonable in regard to this rule but we are receiving complaints that properties, especially those For Sale, are not being properly maintained.

We urge every homeowner in Forest Park to secure the services of someone to maintain their property in an acceptable manner when they are away for any reason. This applies to those having space in the RV area as well.

Notice: 55 and older rule:

Owners of property in Forest Park are also advised that if they rent, lease, or have guests using their dwelling unit when they are not in residence, they must abide by and be responsible for the following rule.

In all cases at least one of the residents occupying the dwelling unit must be at least 55 years of age and all other residents in that household must be at least 30 years of age, except that occupants will be permitted to have children as guests for not more than three weeks in any 12 month period.

FPPOA Board of Directors

Forest Park Folks:

Your Park is a member of SWFROC an organization of 26 similar Parks who own their own property. Along with a couple other resident owned community organizations in northern Florida SWFROC has formed Florida Resident Owned Communities (FLAROC) to have some say on legislation and needs of citizens of Parks like ours.

Your Board will present a petition for your signature at the next FPPOA meeting which is sponsored by FLAROC which asks the legislature to have CITIZENS Insurance (the state subsidized insurance

company many of us

use) alter their policies to offer "replacement" coverage instead of ACV (actual cash value) which factors in depreciation into any claims you might have on your home. This change could help you realize a better result in the event you have a claim with CITIZENS insurance company. The membership of FLAROC is approaching 10,000 citizens of Parks like ours and would be hopefully, listened to by legislators to affect positive change.

HURRICANE PREPAREDNESS GUIDELINES FOR RESIDENTS OF FOREST PARK

Supplies are a critical part of your health and safety and should be gathered in advance of the hurricane. The Activity Building and Clubhouse will be open 8 hours prior to any coming hurricane for you to bring your supplies in and get settled. Both the clubhouse and activity buildings are NOT certified hurricane shelters and in the event of a MANDATORY EVACUATION, residents stay in these buildings at their own risk.

FOOD: Bring a 3-day supply of non-perishable food that requires no refrigeration and needs little or no water to prepare. The following are suggestions: dry cereal, canned fruit, canned juice, instant coffee and tea, ready-to-eat soups, peanut butter, canned vegetables, ready-to-eat meats, tuna, chicken, Vienna sausages, crackers and quick energy snacks, etc. Include a manual can opener, utility knife and cooler.

PETS: Bring a 3-day supply of food and water. Medications and proof of necessary shots. Pets will be housed in the *Activity Building only*.

WATER: One gallon per person per day, enough for 3 days.

COMMUNICATION ITEMS: cell phone and charger and radio with batteries.

CLOTHING: One change per person, rain gear, work clothes/gloves and shoes.

PERSONAL HYGIENE ITEMS: soap, shampoo, deodorant, toothpaste & brush, etc.

BEDDING: Sleeping bag, blanket & pillow. Please no mattresses.

ENTERTAINMENT: Books, puzzles, cards, etc.

HEATH & SAFETY: Flashlight and plenty of batteries.

FIRST AID KIT: Sunscreen, bug repellent, essential medication and Medicare and insurance papers, extra-eyeglasses/contacts & prescriptions, update on vaccinations (particularly tetanus), trash bags.

DOCUMENTS: Store in safe, secure location, such as a safe deposit box. If you bring copies with you, place them in airtight and watertight storage/freezer bags.

SUPPORT FOR SUMMER RESIDENTS USING FOREST PARK WIFI

Please Email Sherrill Wright at sherrillwrightfl@gmail.com with your name and address, if you spend most of your summer in the park. She will keep a list of park summer residents and provide your email address to our monitors if necessary.

The system will be monitored from Doug Ford's summer home. He will be in contact with two full-time residents to help respond to any problems.

We suggest the following steps if you encounter a problem:

- 1. If you are reasonably sure that your computer is not responsible for the problem and you can't get on the internet, do the following:
- 2. Restart (reboot) your computer.
- 3. If you have an outside antenna, unplug the power to it, wait 30 seconds and plug it back in.
- 4. If you still cannot connect call Ann Meacham @ 995.0514 and find out the status of Forest Park WiFi
- 5. If the WiFi is working, do the following:
- 6. FOR LAPTOPS that cannot get online at your house, go to the activity building and connect to Trendnet. This does not require a password and is completely independent of Forest Park WiFi. If OK then try connecting to Forest Park. If you connect to Forest Park in the activity building, the problem at your house must be too low a signal at your house.
- 7. FOR DESKTOPS with an outside antenna. If you have followed step 1 above, call Mark Newsham @ 508.942.3121 or go to his house at 5121 Forest Park Dr. If you bought your antenna from ETHX call them @ 689.1000.

Once you have gone through these procedures, and you still can't connect, your computer may need some technical work done. We suggest you call Paul of Exclusive Technologies @ 898-8840, or Frank Brown @ 980.9927. Both have done work for several computer club members and other residents.

If Ann Meacham is unavailable, you can call Mark Newsham @ 508-942-3121.

Mark is also available, if you want to get online with a new connection, to point and install your antenna. His charges are reasonable and depend on difficulty of installation.
